### Fund Objective

The Alquity Indian Subcontinent Fund is equity focused and targets attractive risk-adjusted returns over the long-term by investing in public companies across the Indian Subcontinent. Our portfolio emphasizes long-term themes, transparency and alignment of management. This is achieved by a fundamental process which incorporates both financial valuation and ESG analysis of material non-financial factors.

### Monthly Highlights

The Indian market bounced back strongly in April, despite ongoing geopolitical tensions in the Gulf.

CPI remained well controlled at 3.4% in March (year on year).

Despite global events, the Reserve Bank of India still expects GDP growth of 6.9% for the current year.

During the month, we exited Syngene (healthcare) and added Billionbrains (digital investment platform) to the portfolio.

### Stock of the Month

Amrutanjan Health Care is one of India's oldest consumer healthcare brands, with a legacy spanning over 130 years. The company focuses on natural over-the-counter pain relief (primarily pain balms), sanitary napkins, and rehydration beverages, distributed through an extensive network across urban and rural India. Amrutanjan benefits from our theme of monetisable structural growth by serving India's vast and underpenetrated consumer healthcare market, where rising disposable incomes and greater health awareness are driving sustained demand. Its sustainable competitive advantage stems from exceptional brand recognition built across generations of Indian households, as well as a broad distribution reach of over one million retailers. We assign Amrutanjan a C grade within our proprietary ESG rating system.

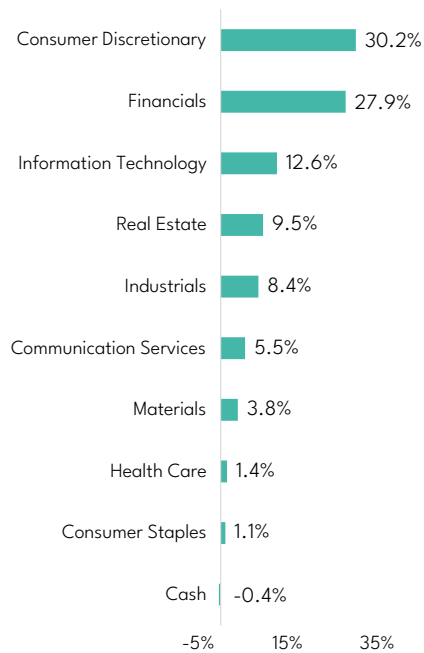

## Sector Allocation



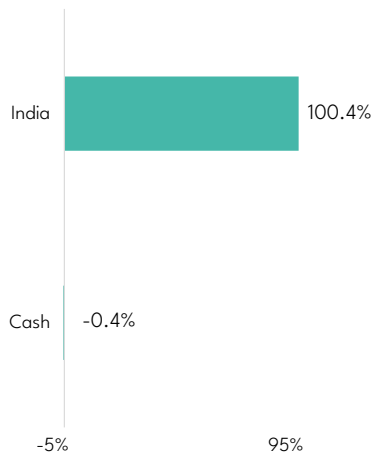
