What is this product?

Type
This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

The sub-fund aims to achieve long-term capital appreciation by investing in Latin America, Asia, Africa, Central/Eastern Europe and Middle East securities. The sub-fund promotes, among others, environmental, social and/or governance characteristics within the meaning of article 8 of Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial services

The sub-fund will invest at least 70% of its net assets in equity securities listed on the regulated exchanges of Latin America, Asia, Africa, Central/Eastern Europe and Middle East.

The sub-fund may also invest in equity securities listed on regulated exchanges outside of Latin America, Asia, Africa, Central/Eastern Europe and Middle East where more than 50% of revenue, income or operating profit is realised in the region, or will be reasonably expected to do so in the near future

The sub-fund will primarily focus on companies that will benefit from the longterm growth opportunities in Latin America, Asia, Africa, Central/Eastern Europe and Middle East. This will include investing in small and mid-cap companies, as well as large-cap companies where the investment manager identifies unrecognised investment opportunities.

The sub-fund will mainly invest, directly or indirectly, in equities.

The sub-fund may also invest in assets such as bonds, Money Market instruments, time deposits, derivatives instruments etc.

The sub-fund may, on an ancillary basis, hold cash and equivalents.

The sub-fund is unconstrained, with a thematic process that incorporates ESG (environmental, social, governance) and impact analysis. The ESG analysis eliminates over 20% of potential stocks that have passed our thematic filter.

Furthermore, in order to meet our desired portfolio characteristics and tracking error, we may optimise the portfolio with reference to a relevant index. It is our intention that the investments contained within the sub-fund will collectively emit lower GHG and use less water than the relevant index.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is suitable for investors who are prepared to accept a high level of risk and who plan to maintain their investment over a medium to long term period. Note: For reference only, investors should consider their own specific circumstances, including, without limitation, their own risk tolerance level, financial circumstances and investment objectives prior to investing in the sub-fund.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

What are the risks and what could I get in return?

Risk indicator

Performance scenarios

What happens if Alquity SICAV is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Skandinaviska Enskilda Banken. AB (publ) – Luxembourg Branch. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 USD is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 4.3% before costs and 0.4% after costs.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
