## What is this product?

**Type** This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

#### Objectives

The sub-fund aims to achieve long-term capital appreciation for investors, by investing in Asian securities. The sub-fund promotes, among others, environmental, social and/or governance characteristics within the meaning of article 8 of Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial services sector.

The sub-fund will invest at least two-thirds of its net assets in equity securities listed on the regulated exchanges of Asia (the Asian region).

The sub-fund may also invest in equity securities listed on regulated exchanges outside of the Asian region where more than 50% of revenue, income or oper-ating profit is realised in the Asian region, or will be reasonably expected to do so in the near future.

The sub-fund will primarily focus on companies that will benefit from the longterm growth opportunities in the Asian region. This will include invest-ing in frontier markets, small and mid-cap companies, as well as large-cap companies where the investment manager identifies unrecognised investment opportunities.

The sub-fund will mainly invest, directly or indirectly, in equities.

The sub-fund may also invest in assets such as bonds, Money Market instruments, time deposits, derivatives instruments etc.

The sub-fund may, on an ancillary basis, hold cash and equivalents.

The sub-fund is unconstrained, with a thematic process that incorporates ESG (environmental, social, governance) and impact analysis. The ESG analysis eliminates over 20% of potential stocks that have passed our thematic filter. Furthermore, in order to meet our desired portfolio characteristics and tracking error, we may optimise the portfolio with reference to a relevant index. It is our

intention that the investments contained within the sub-fund will collectively emit lower GHG and use less water than the relevant index.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended retail investor

The sub-fund is suitable for investors who are prepared to accept a high level of risk and who plan to maintain their investment over a medium to long term period. Note: For reference only, investors should consider their own specific circumstances, including, without limitation, their own risk tolerance level, financial circumstances and investment objectives prior to investing in the sub-fund.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

The reference currency of the sub-fund is expressed in USD. The currency of the share class is expressed in GBP. For this share class, the foreign-exchange risk of the share currency is not hedged against the sub-fund's reference currency.

## What are the costs?
